Pupil Premium and Free School Meals

If your child is eligible for 'free school meals' and you register them for this, the school receive extra funding called 'pupil premium'. We use this extra money to improve the educational provision and resources within school.

What is pupil premium funding?

Pupil premium funding from the government is given to schools to help pupils reach their full potential, regardless of their background or financial situation. It's provided for pupils who:

- Are registered for free school meals
- Have been registered for free school meals at any point in the past 6 years
- Are, or have been, in care
- Have parents in the Armed Forces

At Stokenham Area Primary School we receive up to £1,385 additional funding for every eligible pupil who is registered for free school meals. This extra money could make a real difference to the quality of education we offer. For example, we have previously used pupil premium funding for:

- Educational provision/resources
- Academic interventions
- Teacher CPD to improve Teaching and Learning
- Additional music lessons
- Breakfast Club

If your child qualifies for Pupil Premium, we will automatically credit their account at school with £100. This can be used towards:

- School trips and residentials
- School uniform
- After school clubs on school premises
- Music lessons
- Breakfast club

Is my child eligible for free school meals?

Your child might be eligible if you access:

- Income Support
- Income-based Jobseeker's Allowance or Income-related Employment and Support Allowance
- Support under part VI of the Immigration and Asylum Act 1999
- The guaranteed element of Pension Credit
- Child Tax Credit (provided you're not also entitled to Working Tax Credit and have an annual gross income of no more than £16,190)
- Working Tax Credit run-on
- Universal Credit, provided you have an annual net earned income not exceeding £7,400 (£616.67 per month)

Your child might also be eligible if you ae in a household with no recourse to public funds (NRPF), subject to a maximum income threshold. This is for children of:

- Zambrano and Chen carers (non-EEA nationals caring for a British citizen residing in the UK)
- British National (Overseas) passport holders
- Spousal visa, work visa, or student visa holders
- Those with no immigration status
- Families with a right to remain in the UK under Article 8 of the European Convention of Human Rights
- Families receiving support under Section 17 of the Children Act 1989 who are subject to a no recourse to public funds restriction
- Certain failed asylum seekers supported under Section 4 of the Immigration and Asylum Act 1999

Universal Infant Free School Meals

Currently, pupils in reception, year 1 and year 2 are entitled to a free school meal thanks to a different government funding scheme known as universal infant free school meals (UIFSM). You should not confuse UIFSM with free school meals and the pupil premium.

If your child is in reception, year 1 or year 2 and is eligible for free school meals according to the criteria above, you should still register because we'll receive the extra pupil premium funding and your child will qualify for the £100 family allowance.

Does my child have to eat the free school meals?

No. Pupils who are registered for free school meals don't have to eat them. If you're eligible but you want your child to have packed lunches you should still register because the school will receive the funding which can support your child in other ways.

How do I register?

- Registering is really quick and easy you can apply online at: <u>https://www.devon.gov.uk/educationandfamilies/school-information/school-meals/new-starter-pupil-premium/</u> and get an immediate answer.
- 2. If you want your child to have a free, healthy meal at lunchtime that's great they will get the free meal, saving you more than £350 a year.
- If you don't want your child to have the free school meals, they can continue as normal as long as you qualify and are registered, you still get £100 towards educational activities and school uniform.
